RESOLUTION # 194

A resolution recognizing the visionary and extraordinary contributions of Roscoe L. Holt to the City of Highland Haven and to name the Highland Haven City Hall in his honor.

Whereas, Roscoe L. Holt conceived and *led* the HHPOA Joint Committee from 2000 through 2002 which provided some 250 lakefront property owners with deeds to underwater land and in most cases above water land at the edges of the lakefront. Prior to this effort most lakefront deeds were incomplete.

Whereas, Roscoe L. Holt *led* the Highland Haven Property Owners Association faithfully and effectively as President and Secretary of from 1998 to 2000.

Whereas, Roscoe L. Holt performed annual audits of the HHPOA verifying both financial and bylaw conditions in 2003 and 2004.

Whereas, Roscoe L. Holt *led* the effort to rebuild the RV storage sheds after they were destroyed by a severe storm in 1999.

Whereas, Roscoe L. Holt *led* the city as Mayor of Highland Haven working many, many hours per week assuring the cities business was always in good order from 2004 through 2006.

Whereas, Roscoe L. Holt *organized* the work teams that installed the fire hydrant pipelines in Swan Park and along Blackbird Drive.

Whereas, Roscoe L. Holt conceived and organized the establishment and on-going publishing of the Highland Haven Newsletter.

Whereas, Roscoe L. Holt conceived, organized, designed and *led* the construction of the covered boat shed and new storage sheds which have been a reliable source of income to the HHPOA as well as their designed use for Highland Haven residents.

Whereas, Roscoe L. Holt has *led* the physical preparation of the Community Center for the annual Ladies Club rummage sale.

Whereas, Roscoe L. Holt conceived, organized and *led* the committee to prepare the Comprehensive Property Development Plan for Highland Haven.

Whereas, Roscoe L. Holt *led* the reconstitution of the Planning & Zoning committee which subsequently made major revisions to the Zoning Ordinance to reflect current city conditions and the vision of the Comprehensive Property Development Plan.

Whereas, Roscoe L. Holt faithfully mowed the County Road 125 right of way and the boat trailer storage yard for many years.

Whereas, Roscoe L. Holt *led* the effort to design and install the buoy protection system on the city's waterways.

Whereas, Roscoe L. Holt *led* the effort to construct the Dove Park swimming pier cover in the fall of 1999.

Whereas, Roscoe L. Holt *led* the effort to install the city bulletin board behind City Hall in 1999 and in front of the Community Center in 2005.

Whereas, Roscoe L. Holt *led* the effort to build the stage and install shelving in the Community Center in
